The regular monthly meeting of the highway commissioners of the State of Illinois, County of St. Clair, and Township of Prairie Du Long was held in the office of the town clerk at the Prairie Du Long Township Office Building on June 13, 2023 at 7:30 P.M.

Supervisor Mike Karban called the meeting to order and the Pledge of Allegiance was recited by those present.

Mike Karban, Township Supervisor, presided over the meeting. Trustees John Kaiser, Dean Skaer, Kyle Row, Tim Lubenkov, Road Commissioner Gilbert Birkner and Township Clerk Dana Mehrmann were present.

Supervisor Karban asked the Clerk to read the minutes from the previous meeting. Mr. Karban asked for questions or comments regarding the minutes. Tim Lubenkov motioned to accept the minutes as read. Kyle Row seconded the motion. Motion PASSED.

Three (3) guests attended the meeting Kathy Tullock, Mark Tullock, and Mike Tullock.

The bills against the Township were presented by the Supervisor, reviewed by the trustees and paid.

The bills against the Road District prepared by the Road Commissioner were presented by the Supervisor, discussed and paid.

SUPERVISOR'S REPORT

- Supervisor Karban received notice from the Illinois Department of Revenue in regards to the reallocation of funds in FY24. In short, the revenue received as Personal Property Replacement Tax Allocation will be substantially less and those funds will be reallocated to Local Government Distribution fund.
- Per last decennial committee meeting, Mr. Karban recommended using prairiedulongtwp.il.gov as the township's website.
- The Township's insurance coverage is being renewed with Toirma.

HIGHWAY COMMISSIONER'S REPORT

- Wildwood bids for Live Oak are scheduled to be opened on June 20.
- Hanks will be looking at the culvert where the hole has developed in a wildwood resident's yard.
- The circle drive on Cemetery Rd was approved. Two culverts will be installed and the owner will be responsible for \$500 of the cost.
- Mr. Birkner has been working with the Ford dealer in Greenfield and plans to purchase a new truck next year and will look at a possible tractor for this fiscal year.
- He also contacted Millstadt township in regards to the culvert on Lehr Rd. They too were interested in replacing it and together we will work with the county moving forward.
- Gilbert also plans to hire them to cut back some tree's on Klein Rd once they are fully staffed.

CLERK'S REPORT

- The Township's annual audit has begun using Dale Guebert, CPA's services.


